As parent/legal guardian of the player named on the opposite or attached side of this document, I understand, recognize, and assume that participation in this sport may cause bodily injury to my child during participation or myself during observation. I recognize that any public private facility on which the games are played, or practices are held, the staff, coaches, volunteers, providers of transportation, and Directors of Diamond Baseball of Boulder, Inc., the other players and their parents/legal guardians associated with Diamond Baseball of Boulder, Inc. are not liable for any accident or injury to myself and/or my child(ren) incurred while participating in, observing, or traveling to activities associated with this sport, either in league games, practices, or other events. I fully release Diamond Baseball of Boulder, Inc., its staff, coaches, volunteers, and Directors from any and all liability associated with my child's(ren's) participation, my participation, and my observation of play or practice. I fully understand that participation may include travel, to and from games or practices, provided by Diamond Baseball of Boulder, Inc., its staff, coaches, volunteers, directors, other parents, or players. My release of liability extends to these parties providing transportation. I acknowledge that this release is given voluntarily and I agree that Diamond Baseball of Boulder, Inc., its staff, coaches, volunteers, and Directors are not responsible for reimbursement of medical or any other expenses resulting from any injury

Medical Authorization

I authorize Diamond Baseball of Boulder, Inc., and its coaches, or other representatives to act on my behalf in accordance with its best judgment in case of medical emergency requiring transportation or treatment of injury sustained.

Refund Policy

Diamond Baseball of Boulder, Inc. will consider a refund of your player fee only after a written request is made to the Board of Diamond Baseball of Boulder, Inc., There is no guarantee of a refund, but every factor will be considered. After start of league play there will be no refunds. I also understand the amount on the front of this form under the field labeled "Total Due With Registration" represents only the initial registration fee. I understand that the initial payment of \$250 represents only ½ the player fee. I understand that if I do not pay the full fee by the due date (unless excused by scholarship, in writing), my child will not be allowed to participate. I further understand that the total cost per player totals approximately \$1000 and I commit to making as serious effort as possible in assisting Diamond Baseball of Boulder, Inc. in raising funds to help offset Diamond Baseball of Boulder, Inc. costs.
